### **I. Remote Sensing and GIS Associate**

1. Will have to work in RS and GIS cell established in the office of Director/MRSAC, under direct control of Scientists of MRSAC.
2. He/ She will have to generate GIS database and output as per requirement of the project.
3. He/ She will have to carry out Digital Image processing as per requirement of the project.
4. Considering limited licences he/she may be required to work in shifts from 08.00 hrs to 16.00 or 12.00 to 20.00 hrs.
5. Required to work as per directives from controlling Officer.

### **II. Remote Sensing and GIS Assistant**

1. Will have to work in the office of Maharashtra Remote Sensing Application Centre, (MRSAC) Nagpur, under direct control of Scientists of MRSAC.
2. He will have to digitize maps and generate output as per requirement of the project.
